Identification of Tree(s) and Description of Works

The Willow Tree (WT1) is situated in the front garden of the above named property. It is contained within ours (the home owners) boundary garden. The Arborist of Ransom Hall, Ransom Wood Business Park, NG21 0HJ has conducted a visit to assess the tree and work required. They have advised that "Framework Pollard" work should be carried out to reduce the size of the tree. The Willow is a very large size and leaning heavily to one side which may cause a risk of potential damage to our property.

We have instructed "The Arborist" to carry out the work once Council Approval is granted.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
