Having critiqued the submitted plans and after researching recent and historic crime data at this immediate location I would like to comment as follows:

South Yorkshire Police encourages applicants to build/refurbish developments incorporating the guidelines of <u>Crime Prevention Through Environmental Design</u> (CPTED). Along with enhanced security schemes such as <u>BREEAM</u>, <u>SABRE</u> and <u>Secured by Design</u> (SBD) that offer developers additional security information and accreditation. Enhanced security schemes have been proven to reduce the opportunity for crime and the fear of crime as well as creating safer, more secure, and sustainable environments.

I recommend that the development be built to Secured by Design standards. www.securedbydesign.com Commercial 2023

If BREEAM is a prerequisite of this planning application, it is requested that section Hea06 is conditioned to encourage the planning and implementation of effective measures that provide an appropriate level of security to the buildings, the site, and users.

The level of security at the site should align with the associated risks and the proposed business of the end users. Therefore, it is advisable to adopt a pragmatic approach towards security requirements, even if the specific end users have not been identified yet.

Section 8 of the National Planning Policy Framework 2 states "Planning policies and decisions should aim to achieve healthy, inclusive and safe places which are safe and accessible, so that crime and disorder, and the fear of crime, do not undermine the quality of life or community cohesion..."
