Tree Species: Oak
Tree identifier: T15

Description of works: The tree is approx. 15m tall and the application is to reduce by approx 1m. This is because it is getting too close to the house. The reduction of 1m should still keep the tree very healthy while reducing the risk to the house. The work will be carried out my in compliance with BS3998 by Chris at Firstarbiculture.

Note: the TPO sketch provided was before the the house was build and I have drawn over this to provide the location location

 - $\circ~$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
