We understand from the previous owner the tree is a magnolia (please note we bought the property on the 12th January 2024). This tree has been allowed to grow extremely close to the facade of the property which is a listed building. This is identified as '1' on the attached plan.

The tree has grown extremely tall and we are concerned not only about potential structural damage to our property with it being so close, but potential issues in high winds to not only ours but numbers 8 and 12 as well.

We therefore wish to fell the tree and remove the stump before any damage is caused, and we have been advised

by a structural engineer prior to purchase that it would need to be felled completely.

We are therefore wanting to get this work done as soon as possible.
