Overhanging trees on boundary adjacent to service area, damage caused to local residents sheds.

Carry out a 5m uplift to 1no Oak tree on the entrance to service yard.

To sectional fell to ground level and remove 1no Sycamore and 1no Willow with heavy leans growing over residents gardens.

To to carry out 50% sectional pollards to 3no multi stem willows.
