WORKS TO CONSTRUCT NEW RETAINING WALL ON BOUNDARY

THE APPLICANT'S REAR GARDEN BACKS ON TO A PUBLIC FOOTPATH. ALL THE PROPERTIES THAT RESIDE ALONG THIS AREA HAVE RAISED PLOTS THAT HAVE LARGE RETAINING WALLS, FENCES AND TREES ALONG THE BOUNDARY WITH THE PUBLIC FOOTPATH. THIS APPLICATION IS TO REPLACE EXISTING BOUNDARY FENCE AND EXISTING RETAINING WALL WITH A NEW RETAINING WALL AND FENCE AND TO MATCH THE SAME HEIGHT AS THE BOUNDARY TREATMENTS ON THE ADJOINING PROPERTY. BY MOVING THE RETAINING WALL TO THE BOUNDARY, AS OTHERS HAVE DONE, THEY CAN EXTEND THEIR LAWN AND IMPROVE AMENITY. WHILST THEIR NEIGHBOURS HAVE UTILISED GABION CAGES TO CREATE THEIR WALL, THE APPLICANT PROPOSES A 2M HIGH REINFORCED CONCRETE WALL WHICH WILL BE FINISHED WITH TIMBER PANELS. THE WALL WILL BE DESIGNED BY A STRUCTURAL ENGINEER AND WILL BE CONSTRUCTED UNDER THE UMBRELLA OF BUILDING CONTROL. PHOTOS OF THE APPLICANT'S PROPERTY AND NEIGHBOURING BOUNDARY TREATMENTS ARE PROVIDED WITH THIS APPLICATION ALONG WITH A FULL SET OF SCALE PLANS.
