The tree of concern is one of the ash trees within the garden. We are asking permission to have it felled.

We have been informed by a tree surgeon that both the fully grown ash trees in the garden were suffering from "ash dieback " disease and would eventually have to be felled. One of the ash trees is situated adjacent to the west wall of the garden- please see attached map. The house is a grade 2 listed building and I understand that, because of this, the stone walls that surround the garden are also covered by the listing.

The ash tree of concern overhangs a vehicular access to 5 five further neighbouring properties. The tree roots are beginning to compromise the structure of the wall on the garden side. If the ash or branches of the ash were to come down in a storm it is likely to cause damage not only to the wall but to the neighbours' property and vehicles.
