All trees to be raised to 3m over parking area and 2.5m over grassed area.

To reduce extended limbs where required back into the natural crown to optimise structure against windsheer after a limb recently broke out. Approximate reduction meterage is up to 3m. We do not intend to reduce any height or the main crown line itself.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
