- T1 Pinus sylvestris. reduce canopy by 2m due to imposing size which hampers reasonable enjoyment of outside space and to achieve uniform crown shape. **final crown spread following proposed works to be measured at 5.5m south, 7m east, 7m north and 7m west, height to be brought down to 12.5m. current dimensions measure at 6m S, 9m E, 9m N, 9m W, height is 14m.** any branches close to dwelling are to be pruned to give 2.5m clearance from Gutters.
- T2 Pinus sylvestris. fell to ground level due to poor health: tree exhibits sparse canopy due to suppression from T1, major deadwood and hollowing of stem base on west side
- G1 Holly and Laurel mixed hedge. trim lateral branches to boundary line and reduce height by approximately 1.5m to achieve uniform height of approximately 3.5m **current height is 5m**
