## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1-Beech: As per the case officers report TP\_18\_00562\_X-CASE\_OFFICER\_REPORT-2231465 dated 2018. The tree has historically been pollarded which subsequently requires tree management in order to maintain the reactive growth as a result of such arboricultural practices being carried out. The tree is a large tree located close to both adjacent properties. The pollard has supressed the trees size within the relatively small area is has to exist and now requires some basic remedial works.

Undertake a full crown reduction of no more than 1.5m from the tips inwards via the removal of tertiary and secondary branches only. Ensuring that no pruning wounds exceed 45-50mm in diameter and that all cuts are brought back to viable growth points.

Tree work was carried out in 2018 to manage the tree in the same way that the above specification for work intends to do so.

This work will not affect the amenity value of the tree nor will it be detrimental to the health of the tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
