T1 - Holm Oak (Quercus ilex) - The works i was to carry out consist of - Crown reduce by 25% (2-2.5m) to suitable growth points, remove deadwood, crown lift to 3m and crown thin by removing crossing/ rubbing branches (15%).

T2 - Holm Oak (Quercus ilex) - The works i was to carry out consist of - Crown reduce by 25% (2-2.5m) to suitable growth points, remove deadwood, crown lift to 3m and crown thin by removing crossing/ rubbing branches (15%).

T3-T12 - Holly (Ilex aquafolium) - The works i was to carry out consist of - Reduce in height by 3m to suitable growth points, remove deadwood and prune back branches encroaching on neighbouring property to boundary line (2m).

T13 - Oak (Quercus robur) - The works i was to carry out consist of - Reduce canopy by 25% (2-2.5m) to suitable growth points, remove deadwood, crown lift to 3m and crown thin by removing crossing/ rubbing branches (15%).
