Statement of work:

T1 Elderberry - Rear RHB: To remove major deadwood and reduce the remaining canopy/radial spread by up to 1 metre and maintain a natural shape. Height to remain at 8 metres and the radial spread to be reduced from 4 metres to 3 metres.

T2 Plum - Rear LHB: Crown Reduction - To reduce the height and radial spread of the canopy by up to 2 metres, to shape accordingly and remove major deadwood. To include all overhang on the neighbouring side. Height to be reduced from 6 metres to 4 metres and the radial spread to be reduced from 4 metres to 2 metres.

T3 Laburnum - Rear LHB: Crown Reduction - To reduce the overall height of the canopy overhanging the neighbouring out building by up to 3 metres, cutting back to appropriate growing points where possible and remove major deadwood. Height to be reduced from 6 metres to 3 metres from over the neighbouring outbuilding.

Reason for work: General Maintenance.
