Change of wording of condition, to permit a safe & logical sequence of ground works, so foundation to retaining walls and support columns can proceed ahead of surface water drainage works. This will avoid dangerous & abortive works, where foundations are constructed after the installation of surface water holding tanks - risking ground de-stabilization, unsafe working conditions, displacing tanks and drainage pipes.
