Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The tree is marked 'Bay Tree' on the attached plan.

To remove and replace a BAY TREE which despite regular pruning has overgrown its location, become misshapen and become impossible to safely maintain due to its height and diameter. Indeed, one recent attempt to maintain shape and height led to a fall from height for the homeowner necessitating a trip to the minor injuries hospital and stitches to cuts in the head. The top of the tree is in excess of six metres tall and it is necessary to reach three to four metres to maintain the middle upper section.

The scale of the tree also means that much of the work required to maintain it necessitates the use of ladders and extended pruning and lopping equipment with a consequential health and safety risk.

The tree is situated in a small traditional ornamental garden of box hedging and lavender which it has come to dominate. Once removed the tree will be replaced with a similar smaller specimen more in keeping with the scale of the rest of the planting and which can be kept in ornamental and attractive shape.

The tree is adjacent to other gardens. It has a significant shading impact on these gardens depending upon the time of day. The density of the leaves causes shade and shadow to the affected gardens. This deep shade detrimentally affects the amenity of the homeowner's garden.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
