It is proposed to install white Anti Slip Tape (50mm wide) on the steps including both the new steps on the approach and the original granite steps of the White Bridge. The anti slip strips will serve two purposes and aim to improve user safety on the bridge. The strips will provide an anti slip strip on the original smooth granite steps which can be slippery when wet and they will also provide a colour contrast to help improve visibility of the steps for bridge users.
