



Existing Part Ground Floor Plan Scale (1:100)




Existing First Floor Plan Scale (1:100)




Existing Front Elevation Scale (1:100)



Existing Side Elevation Scale (1:100)




Proposed Part Ground Floor Plan Scale (1:50)




Proposed First Floor Plan Scale (1:50)

Proposed Site Plan Scale (1:500)


