Beech Tree in south corner of garden needs to be reduced in size. I want to reduce the overall height by 2 metres and lop the branches overhanging my neighbour's driveway. Branches on other sides of this tree also need to be lopped by a proportional amount to retain the shape of the tree. I also want to reduce the crown of 2 other trees in my garden by 2m. One is a prunus and the other is a copper acer. They do not have TP orders on them.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
