Located in rear garden of neighbouring property. Tree overhangs boundary significantly and the crown is considerably on sided. Remove 2 large limbs overhanging boundary in order to re=shape and mitigate branch failure at union forks You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
