Goals:

• Lateral crown reduction by removing 2.5 to 3.0 metres growth in spread pruning back to suitable growth points

to leave a natural looking crown as possible.

Using hand tools only to give the best finishing cuts.

Trim/prune back hedges in line with the Laurel hedge closest to the house within this group

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
