In order to protect a young silver birch tree which is struggling to flourish (much smaller than another silver birch tree we planted at the same time) we would like to cut back 5 or 6, 3cm diameter branches about 2 metres to their growth point. You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work. Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements). Please provide the following information: · Tree species · The number used on the sketch plan; and · A description of the proposed works.
