Below description is based on the site meeting with IWC Tree Officer:

G1:

- Remove dead and collapsing trees.
- Remove trees leaning at an angle of 10% or more towards the road (only trees at risk of falling into the road in the event of failure).
- Remove any Ash trees suffering from Ash Dieback with less than 50% canopy cover.
- Remove deadwood from retained Ash trees on the roadside (re-assess for Ash Dieback in the summer / when in full leaf).

G2:

- Remove dead and collapsing trees.
- Remove trees leaning at an angle of 10% or more towards the road (only trees at risk of falling into the road in the event of failure).
- Remove any Ash trees suffering from Ash Dieback with less than 50% canopy cover.
- Remove deadwood from retained Ash trees on the roadside (re-assess for Ash Dieback in the summer / when in full leaf).
- Remove self-set trees up to 15-20cm diameter.
- Remove vegetation.
- Remove non-native species.
