T1 Horse Chestnut (Aesculus hippcastanum). Excavate by hand tools within the root protection area to create a foundation for a conservatory to be built under Certificate of Lawfullness. Roots under 25mm in diametre will be pruned in accordance with BS 583 72012. Roots above this will be retained and wrapped in hessian and sealed with tape to prevent concrete contact. The foundation will be built around these roots with a growth allowance of 50mm.

Other trees are included in the site plan but no works are required to these trees.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).
