Following the visit on 19 January 2024 by Martin Jenkins, NCH (Arb), Tech Cert (ArborA), TechArborA and a Lantra qualified Tree Inspector, the following was discussed and agreed with the homeowner / applicant:

(2) 2 Ash on side boundary. These trees have limited space to develop, fell to near ground level.

(4) Field Maple and Norway Maple to the right. These are becoming too large for their positions. Reduce height by 2.0 - 3.0m to leave not less than 7.0m and reduce spread by 2.0 - 3.0m to leave no less than 6.0m.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
