**Existing materials and finishes:**

One existing red clay brick gable end wall of the cottage on the north side of the proposed new car port One existing 1100mm high brick boundary wall on the south side of the proposed new car port.

**Proposed materials and finishes:**

The car port will have 6no. oak timber support posts, each 200mm x 200mm with oak support beams above the posts. The south upper triangular gable end wall of the car port will be vertical timber boards either close fitted together or with a 5mm gap between each board. These boards will be oak or softwood boards with a preservative wood stain finish (eg dark grey, to match the slate roof colour). Oak barge boards with weatherproof the top edge of this board cladding, fixed immediately below the edge of the roof slates. The above mentioned existing brick walls will be retained.

The existing cottage has a grey natural slate roof covering with grey angular ridge caps.

**Proposed materials and finishes:**

The proposed new car port will have natural grey roof slates and grey clay angular ridge caps - to match the cottage roof.
