T1 - Oak - Fell to prevent outgrowth of location. Tree is showing signs of significant damage caused during the construction of the house which is positioned very close to the tree. Homeowners are worried about potential damage to foundations now and in the future as well as it's likelihood of failure due to existing damage.

T2 - Ash - Reduce Eastern side of Ash by approx 3m and Western side by approx. 2m, removing lower lateral limb to balance, as per annotated picture enclosed.

T3 - Walnut - Trim crown by 1m all round to prevent outgrowth of location

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\;$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ\;$ showing the approximate distance between the application tree(s) and buildings
 - $\circ\;$ adding other relevant features on the site (e.g. greenhouse, paths)
