T1 - Italian Alder - This Tree was, at one time, multi stemmed. Now only 2 stems remain as the other have torn out due to bark inclusion and rot at the base. Of the remaining two stems, one hangs precariously over the road. The other has a progressive lean and is now over the sub station.

This tree now raises obvious liability concerns for the owners, due proximity to the sub station and its position over the road. Request removal to near ground level.

T2 - Mature Lime - This tree has not been worked on in many years. There is excessive epicormic growth in the center crown. It is also exhibiting large amounts of deadwood.

Request 15% Crown thin, and removal of major deadwood.

T3 - Mature Lime - This tree has not been worked on in many years. There is excessive epicormic growth in the center crown. It is also exhibiting large amounts of deadwood.

Request 15% Crown thin, and removal of major deadwood.

T4 - Semi Mature Sycamore - This tree is twin stemmed. The lesser stem is now completely dead due to sooty bark disease. The main stem is now in decline.

request removal to near ground level

G1 - Row of 17 Semi Mature Leylandiis - These trees are starting to become very dominant and offer little in the way of amenity value. They have of late also started to encroach on the sub station behind. The owners are concern about liability due to the leylandiis proximity to the sub station.

Request removal to near ground level. To be replaced with native broad leafed species in more suitable location.
