

It is intended for the purpose of reporting tree condition, ascertained from ground level at the time of inspection, and to bring to the attention of the owner(s) of land upon which trees are situated, trees identified as obstructing or endangering the public right of passage along the highway, or a likelihood of danger arising from trees or part thereof falling on the highway by reason of their condition. It should not be interpreted as providing a comprehensive examination of every tree adjacent to the highway. Included are recommendations for the purpose of removing the cause of the obstruction or danger, or the likelihood of danger arising from the tree(s). Additional notes

Protected trees

Where any tree to which this report relates is subject to a Tree Preservation Order (TPO) or is in a Conservation Area, North Norfolk District Council must be notified in writing of the proposed work at least 5 working days prior to the date on which the works are to be commenced. There is an expectation that protected trees shall be replaced by the owners as soon as they reasonably can with trees of appropriate size and species. The removal of dead branches from living trees which are protected requires no prior notification. With the exception of dead trees or trees within a garden or churchyard or subject to any other exemptions, a felling licence shall be required for the felling of all growing trees. No part of a protected countryside hedgerow (hedgerows at least 20m long or which meet other hedgerows at each end and which, in each case, are on or adjacent to land used for certain specified purposes) shall, unless subject to exemptions, be removed without first notifying North Norfolk District Council. Protected countryside hedgerows do not include hedgerows within or on the boundary of a residential property. Further information can be found at the Hedgelink website (https://hedgelink.org.uk).

Protected sites

Natural England's written consent may be required before carrying out any activity which could affect a Site of Special Scientific Interest (SSSI). Lists of operations requiring Natural England's consent for each SSSI can be found using the Designated Sites View (https://designatedsites.naturalengland.org.uk). If you are also applying for a felling licence for an operation within a SSSI then it is recommended that you send the Forestry Commission a 'Supplementary Notice of Operations' alongside the felling licence application. Guidance can be found at https://www.gov.uk/guidance/protected-areas-sites-of-special-scientific-interest.

Norfolk County Council's Natural Environment Team should be consulted before carrying out any work within or near to a European site protected under the Conservation of Habitats and Species Regulations 2017. This includes any land designated as a Ramsar or Special Area of Conservation (SAC) or classified as Special Protection Area (SPA). The Natural Environment Team can be contacted at NETI@norfolk.gov.uk. The location of SSSI's, SAC's, SPA's and other protected sites can be found using the Magic Map Application (https://magic.defra.gov.uk). Where Norfolk County Council consider the work likely to have a significant effect on such a site's conservation objectives (either alone or in combination with other plans or projects), Norfolk County Council will prepare a Habitat Regulations Assessment (HRA) and consult Natural England on your behalf. Any mitigation measures included in the HRA must be adhered to so to remove or reduce any adverse effects on the site's integrity during the course of the work.

Additional notes

Protected wildlife

Reasonable steps must be taken to avoid inflicting harm upon any wild animal or causing disturbance or damage which would be likely to impair the animal's ability to survive, reproduce or to rear or nurture its young. Where necessary as a precaution, it is recommended that works are conducted outside of the bird breeding season, normally taken to mean between March and August, and where possible, conducted during September/October to avoid maternity and hibernation seasons when bats are most vulnerable to disturbance. Information can be found at the Bat Conservation Trust website (www.bats.org.uk). If European protected species (EPS) are found during the operation, work must cease until an assessment has been made, in consultation with an ecologist, as to whether the work can proceed without a 'Mitigation Licence' being granted by Natural England. The consultant ecologist will be able to provide support during the application process and must be appointed to assist in the preparation and the delivery of the mitigation proposals. Street works

For the purpose of executing the required works safely, where it is necessary to temporarily stop or limit vehicular and/or pedestrian traffic along the highway, an application should be made to Norfolk County Council. In most cases a 'Notice of Works – F38' form should be completed. Where it is necessary to close the road, a 'Temporary Traffic Order – F45' form should be completed. for works durations of up to 3 days the application should be submitted at least 3 days prior to the date on which the works are to be commenced; or where the duration of the works is likely to exceed 3 days the application should be submitted at least 10 days prior to the date on which the works are to be commenced.
