Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Maintenance work to three trees at 3 Bishops Down Cottages, as done in previous years. Keith Chalmers of 'Treework' has advised on the proposed works.

1) Small beech tree B4 just behind roadside hedge. Reduce overall crown to last pruning points (no more than 3 metres) to maintain the size of this tree in proportion to the nearby silver birch, to reduce overcrowding.

2) Smaller beeches in hedge between properties (B2 and B3). Reduce overall crown to last pruning points (no more than 3 metres) to reduce the crowding between these trees and with others nearby, to make them more consistent in size with our hedge of which they form part, and to reduce overhang on neighbouring property.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
