T1 - Monterey Cypress

Dismantle in sections to near ground level and grind out stump to allow replacement planting.

Reason for works: The tree has recently shed a large limb which narrowly missed the neighbouring property 'Sanditon', but did cause damage to infrastructure at Sanditon. Further limb loss is expected to be seen in the relatively near future. There is a signification area of bark necrosis and dysfunction on the southern aspect of the main stem which could be the cause of the large amount of dead material that was removed in 2023. The presence of Coryneum Canker, Seiridium cardinale, cannot be discounted.

A replacement tree will be replanted following stump removal and alleviation of the ground conditions. Recommend a standard Pinus sylvestris 8-10cms girth or a Quercus spp depending on supply costs which could be considerable for the Pinus.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
