T1 - 1x Spruce tree - In back garden, To fell, due to sparse & declining canopy.

  - $\circ~$  showing the approximate distance between the application tree(s) and buildings
  - $\circ\;$  adding other relevant features on the site (e.g. greenhouse, paths)
