T1. Evergreen oak:- lift over road to 6 meters clearance [ branches are pushing heavily on wires) T2 Sycamore[ By garage] Remove 5 lower limbs low over garage roof. T3 Sycamore x5 [group]:- Fell [ some have decay and included bark union if removed remaining trees will be out of balance]. T4.Sycamore :- lift canopy to 2.5 meters over lawn. T5. Ash [ this is a small spindly ash with top die back ,others seem ok for now]. T6 Larch [ dead] :- Fell.
