Millburn Grange Farm Accommodation Overbridge comprising:

Building – Millburn Grange Farm Accommodation Overbridge including parapets;
Earthworks, including wingwalls, to facilitate the overbridge; and
Fences and Walls – Safety guardrails situated on top of the wingwalls, approximately 1.08m in height and vehicle restraint systems.

The works are in the vicinity of Kenilworth and are approximately 0.5km to the north of Kenilworth. The existing Coventry to Leamington Spa rail line is approximately 0.02km to the west of the works and the A429 Kenilworth Road is situated approximately 0.27km to the west of the works.
