Whole crown reduction and crown lift to 12 to 20 m above ground level, to provide sufficient clearance to property.

Two trees on the grounds of 74 West Heath Road. A really big tree is located on the inside wall of the white entrance wall and the second three is adjacent to the main road. I have no reports only photographs which i am unable to upload to show you. The trees need to be crowned as they overhanging onto the street and road. The poisonous fruits from the trees, when they fall are littering the streets and road making walking and driving difficult.

Unfortunately I don't know the tree species or the tree number if one has been allocated.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
