Description of Proposed Works
Please describe the proposals to alter, extend or demolish the listed building(s)
The proposed works include the removal and rebuilding of the stone handrail and balustrade including replacement of damaged and defective balusters. Repairs to the retaining walls and steps are also included. Works to the pathway to the north of the balustrade are also included comprising the installation of a number of concrete pads to allow safe access for a crane to allow installation of sculptures on the terrace and adjacent gardens. The proposals are detailed in the drawings which accompany the application. In relation to the stonework repairs and replacements, all work will be carried out carefully by suitably qualified and experienced contractors. Traditional materials will be used, supplemented with modern fixings etc, as appropriate and new stone will be sourced to match the existing and all profiles of balusters and the like, worked to also match the existing. On completion, the structure will be largely unchanged from the existing, albeit with missing and defective areas of stonework replaced and made good. The concrete pad foundations comprise 2.1m x 2.1m x 0.8m concrete pads, located to accommodate lifting positions for the crane which is
used by YSP to install and remove sculptures and artwork on and around the Terrace. The pads will be located at a depth of 300mm below the gravel surface and will therefore not be visible once the works are completed.
