- T1 Lawson Cypress- Remove dead tree.
- G1 3no. Pine Prune to remove all partially split/failed branches from applicable canopies. Prune northern tree within group to remove ≈ 75mm tertiary branch arising to south to facilitate 5m clearance over Stockeld Road.
- G2 2no. Cherry Prune to attain ≈ 1.5m clearance to adjacent church building roof to south.
- G3 Lawson Cypress Prune to return to managed length of hedge
