T1- Malus sylvestris (Crab apple) Rear left corner-

- Climb to reduce in height by approximately 1.5m from 7m down to 5.5m and average radial spread by approximately 1.5m from 5.5m to 4m.

- Thin crown by removing rubbing/crossing branches.
- Remove major deadwood.
- T2- Malus (Apple) Rear boundary-

- Climb to reduce in height by approximately 1.5m from 5m down to 3.5m and average radial spread by approximately 1m from 6m to 5m, being sure to reduce the side overhanging the neighbours back to the vicinity of the boundary line.

- Thin crown by way of removing water shoots and rubbing/crossing branches to improve light flow to the centre of the crown.
- Remove major deadwood.

Reason for Works: general maintenance for future retainment.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
