The Yew Trees have grown over the adjacent road (Blackberry Lane) and have contact with high sided vehicles. The application is to reduce the length of the branches to make it safe for road users and balance the rest of the tree with similar length branch reduction all the way around.

Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

TPO number: (EH221)89 - Request to carry out a 15% crown reduction and all round balancing and thinning of two Yew Trees (T1 and T2) that currently over hang the adjoining pavement and highway (Blackberry Lane) and are in the direct path of high sided vehicles near to junction. The two trees are adjacent to each other and present as one canopy. They are located just inside the southern boundary of Flintstones, 45 Lymington Bottom (inaccurately named as Kings Drake on TPO documentation).

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
