## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

We seek permission to remove two apple trees. One a Bramley and the other a domestic desert apple tree. Both are heavily colonised by ivy. Both are showing signs of death and decay. A major bough of the smaller of the two (tree 2 on the sketch) fell within the last 2 weeks exposing rotten wood through the tree.

The trees are located within a tarmac covered driveway to the north of our house. It measures 20m by 12m. Further to the north of the driveway is a vegetable garden.

There is a risk of one or both trees collapsing, endangering property and potentially persons. We also need access to the area on which they are sited to undertake necessary work on the drainage of our house.

We currently have a septic tank that also collects roof water from our house. These needs to be changed to comply with recent legislation. The current septic tank sits within the vegetable garden described above. The foul pipe, therefore, crosses the tarmac driveway. We plan to site a digester or cesspool within the tarmac driveway and connect the current pipework. To gain access to the pipework and to provide a site for the treatment plant/cesspool the trees would need to be removed.

The trees now are not productive, are being killed by ivy and already have started to collapse. They are sited behind a privet hedge and add little to the street scene as they are not high enough to be seen over the hedge to any significant degree.

We have already planted four apple trees within the garden proper to replace them.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
