## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Tree T1 is a mature Beech tree located approximately 4 m from the main house. It is approximately 15 m in height, has a trunk 0.82 m in diameter and has a very extensive and well-developed canopy over the adjacent house.

I have had a tree survey carried out (by a qualified tree surveyor) and the tree itself appears to be generally healthy. However, the following concerns are apparent:

The beech tree is located too close to the house (even allowing that the tree would have been smaller when the house was built). The root protection zone is 9.84 m but the house is within 4 m of the tree. This is contrary to recommendations within BS 5837 and limits the extent of the tree root to the east. Whilst a small intrusion into the root protection zone would be acceptable, the extent of intrusion causes concern.
Additionally, the beech tree is situated on a steep bank with poor soil profile limiting the root profile to the south.

- The canopy is crowded and there are mature trees adjacent the tree T1.

We have suffered from two tree collapses in our garden in recent years and two neighbours have also had major tree collapses in the last year. Given the maturity, age and overall weight of the tree, we are extremely concerned that this tree will eventually collapse in a storm due to root failure, not due to failure of the trunk. Due to the tree's location, this would be a threat to life as well as extensive building damage. The concern is such that when it is windy, we do not use that side of the house. Our concern is exacerbated by the outcome of the tree survey which highlights the limitations on the root structure in two directions and the general shallow depth of a Beech tree roots.

We have discussed whether it would be feasible to substantially reduce the height of the tree as an alternative but this is impractical due to the height at which the canopy starts. Additionally, any crown reduction or crown thinning works would need to be extensive and are likely to risk the health of the tree and ultimately not resolve the root issue.

Given the potential risk to life, we would ask to remove the tree in its entirety to mitigate the risk that it will collapse onto the house and cause injury or death. There are numerous other trees in the area of the garden and therefore we do not consider that this will have a substantial impact on the overall greenery in the area and would not propose to replace the tree as a result.

  - $\circ\;$  showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
