Reduction of crown, general tidying up and lifting; whilst maintaining health of the tree- same as approved works granted in 2006 ref 06/01571/T

The tree has grown excessively since the last approved works in 2006. It is currently taller than the length of garden to the house and shades the entire garden killing any plants.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
