The tree is in close proximity to the clients property and some branches are contacting the service cables.

Remove approximately 3 number of branches from Holm Oak as indicated in image 562RIDOAK to provide sufficient clearance (approximately 1.5-2m) to adjacent service cable & property.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
