Old Prunus (Cherry) (T1) Stump on front right of boundary. Fell to as close to ground level as possible.

Pyrus (pear) (T2) Rear left boundary. Fell to as close to ground level as possible.

Photinia x fraseri (Red tipped Photinia). (T3) Rear right boundary. Trim to tidy removing no more than 1m from height and spread.
