I received an email from Christine indicating that we should have applied for Change of Use on the Annexe before renting it out on a long term basis. She advised me on how to go about this.

Christine was alerted by the Council Tax department. We registered the Annexe for Council tax knowing it would be liable for CI once it was rented permanently. We were unaware we should have applied for Change of Use first.

We have gone on a year's sabbatical and have been looking for a tenant for the whole property- main house with Annexe included. We have been unable to find a tenant who wanted the Annexe as well so we decided to rent it out separately (unaware we needed PP). We found a suitable tenant for the Annexe straight away but are still looking for a tenant for the main house. We intend to return in a years time. We do not know whether we will want to continue renting the Annexe (should we be granted PP) but would like to keep the option open so we are applying for Permanent Change of Use.
