Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

It's a copper beech tree which sits between the edge of our house and the street. It's at least 50 years old. It's much too big for the area it's planted in, and if it's left to grow large branches it breaks the phone lines and interferes with the electricity lines. British Telecom used to pollard the tree annually to keep their wires safe. In the 90s they stopped doing that and we took over the job. Every year we have been pollarding it to a safe level. Last year we received a complaint from Redland and cotham parish council. In order to do the right thing, we are applying to do the pollarding so that you can guide us on what the safest and fairest thing to do to balance functioning local amenities and the growth of the tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
