Boot Room - believe this was an extension to the existing property, propose to enclose one door opening, with matching materials on the exterior. On another elevation take out existing glazed screen and re-use original timber door and frame, close up walls to materials to match existing. Also, remove glass sheets from current roof and install Black Velux Conservation Roof.

Master Bedroom 1st Floor - Existing Floor has a slope North to South approx. 120mm, existing floor to remain and install floating floor over the top - so it can be removed. then reinstate carpet dressed over the levelled floor. Create master suite walk in wardrobe - form opening with stone wall to create 900mm door way with Oak Timber lintel - to keep in keeping of building.

Within rear garden install 10m x 5m x 2m deep swimming pool
