Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The intended work is to reduce and thin out the canopy on both trees, reducing branches extending towards the house roof and front elevation and also to reduce the overhanging branches above the pavement and roadway, as a safety measure, to prevent large branches falling on to school children, other pedestrians and road users. Historically, the tree roots have entered the main drain located on the driveway, and this work will prevent any further continued breech in the drain system.

The trees are positioned less than 8.0metres from the property front elevation and foundations. The trees are approximately 12.0metres tall, and therefore, these mature trees are considered too close to the property. This is well documented within official technical books.

The house is prone to seasonal movement and this is thought to be subject to the trees location. Ideally these trees should be removed and replaced with much smaller tree species, however as a minimum, they now require the canopies pruning/ cutting back. BMBC planning consent was last given in 2014.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
