T1 - Japanese maple. Reduce canopy on the south aspect only by c. 1.5m to c. 500mm from the trunk. No height reduction required. Works are required to implement scaffolding to enable the construction of RBWMC consent ref. 22/01700 at 127-128 High Street.'
