Identification of Tree(s) and Description of Works

As a bit of background, Montacute school is a school for complex learning difficulties and disabilities and has many non-neurotypical pupils on its campus.

An incident has occurred recently whereby a pupil ingested Holly berries from a tree located within the school grounds. The school nurse called the poisons advice line for healthcare professionals who recommended that the pupil go directly to A&E as they had a reaction in the form of a rash. Thankfully the child has recovered, but in order to prevent this from happening again the school would like to take action to mitigate the problem. I would like to stress that under different circumstances, other options could be looked at, but in this case, it is advised that the problem should be removed entirely by effective management of the woodland areas.

We are wanting to remove approximately 6 or 7 Hollies that have berries on them and 1 young Yew (see photos attached). The Hollies are located within two Woodland TPO areas titled W1 and W2 (see TPO map attached). Additionally, the school would like to apply for a caveat that would enable them to remove any Hollies in the future that begin to produce berries. As all Holly trees on site are young mature and only make up a small percentage (approximately 5%) of the overall flora within W1 and W2, this would not have a large overall impact on the area. There will also be a number of Holly trees remaining as they aren't currently producing berries.

As the areas are covered by Woodland TPOs the school are keen to manage the areas as close to the current condition as possible both for the benefit of the pupils who use it as a woodland school/outdoor area and also for the amenity of the wider area. This would mean replanting/re-stocking as required with suggested species such as Hazel, Birch, Oak etc. Species that are native and already present within the area.

As this is a matter of safety for the pupils the school would value expediency in receiving a response.

 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
