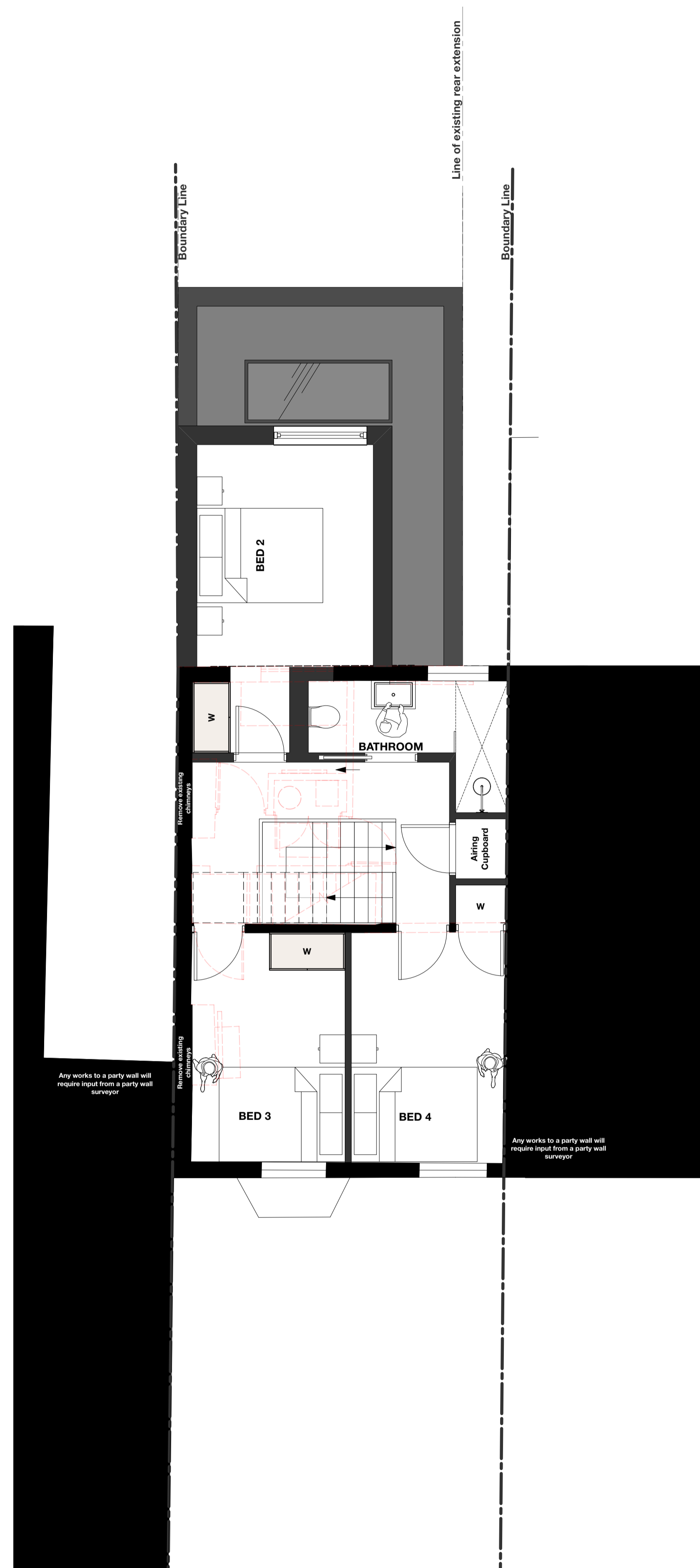
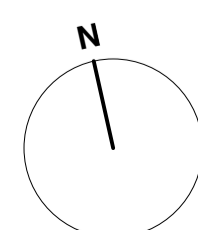

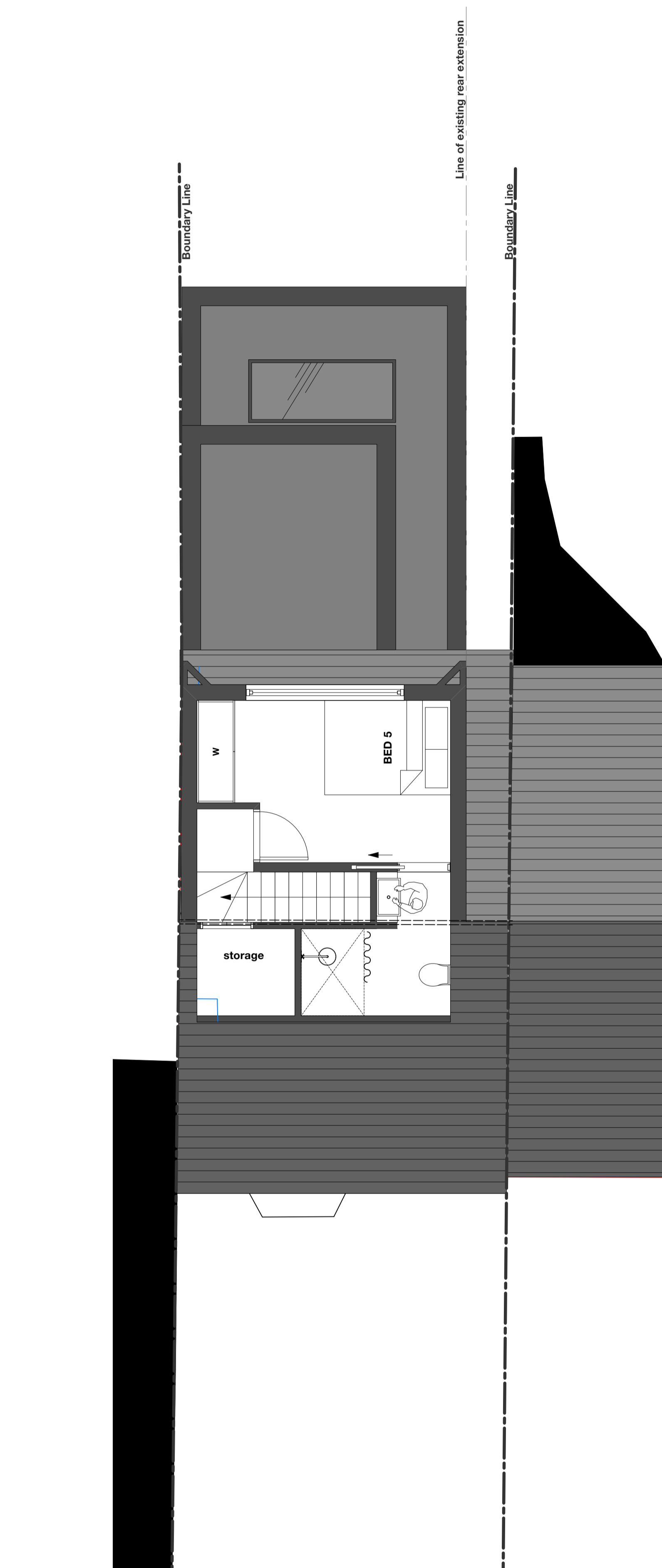
**PROPOSED GROUND FLOOR**
