## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Proposing complete removal of Oak Tree marked as F6 on the attached plan from Nottingham County Council.

The proposed work will be carried out with use of a MEWP and climber in the tree to sectionally dismantle the entire tree and then chip and remove from site.

A letter (copy of which is attached) has been received by VIA, on behalf of Nottinghamshire County Council, advising Mr Posaner that urgent work is needed in order to protect the public and road users.

As shown in the attached photos, on personal inspection of the tree has severe rot and Ganoderma brackets on the main stem, and the canopy including major limbs over the house are starting to deteriorate and die.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
